DELIVERIES: Unless otherwise specified, deliveries will be made in accordance with the Company's automatic Weather-Watching Service. Use of this service does not nullify the customer's basic responsibility to see that an adequate fuel inventory is on hand. It is the responsibility of customer to maintain clear approaches to the fill location.

The Company shall not be responsible for failure to make deliveries due to conditions beyond its control including but not limited to strikes, fire, accidents or government regulations.

Statement of Fair Credit Billing Rights

"If you think your bill is wrong, or if you need more information about a transaction on your bill, write us at the address shown on your bill as soon as possible. We must hear from you no later than 60 days after we sent you the first bill on which the error or problem appeared. You can telephone us, but by doing so will not preserve your rights.

In your letter, give us the following information:

- Your name and account number
- The dollar amount of the suspected error
- Describe the error and explain why you believe there is an error. If more information is needed, describe the item in question.

You do not have to pay any amount in question while we are investigating; however, you are still obligated to pay the parts of your bill that are not in question. While we investigate your question, we cannot report you as delinquent or take any action to collect the amount you question."

Federal Equal Credit Opportunity Act

"The Federal Equal Opportunity Act and comparable provisions of Massachusetts Law prohibits creditors from discriminating based on race, color, religion, national origin, age, sex, marital status or the fact that the applicant is a recipient of public assistance or has in good faith exercised any right under the Consumer Protection Act.
